Minutes of the Parish Council Meeting of Neatishead Parish Council held on Thursday 19th October 2023 at 7.30pm at New Victory Hall, Neatishead

2. Declaration of Interest and applications for dispensations

Cllr Hanger declared an interest in the Poor's Trust

3. Minutes of the previous meeting

Location of the October meeting in the minutes was incorrect. Minutes amended and agreed

4. Public Speaking

a. County Councillor

Cllr Price reported the recent meeting held by Duncan Baker MP, focusing on speeding in rural areas, had been well attended and informative. Possible legislation changes to manage repeat speeding offenders were being considered. Cllr Price is trying to obtain an Automated Number Plate Recognition (ANPR) camera to trial in his parishes for a year. The highways department and the police would agree suitable locations for the device which would be operated by two volunteers. Cllr Price provided an update on the distribution of extra funding available for sea defences in coastal areas.

He confirmed the Road Safety Community Fund the parish council had applied for in October 2022 for a reduced speed limit in the village, had not been successful. The fund was paying for new roundels in the village. He suggested the parish council apply for the Parish Partnership Scheme funding to pursue other speed control management options. It was agreed the clerk would look into this.

c. Police

The clerk read a report submitted by PC Pritty: No crimes of note over the past month, we have had three calls to the police from the Neatishead parish, 2 x were nonattendance and 1 x was an unfortunate death on a boat at the staithe (nothing suspicious) I've been doing my usual patrols around the school with no issues to report. On more than one occasion recently the local camp/caravan site on School Lane has had the sign defaced, this is obviously causing concerns for the owner as it happened more than once and the owner is keen to know why they are being targeted, this is being looked into as criminal damage and

harassment, luckily following a recent incident our crime scene investigator has managed to secure some DNA evidence from the scene.

d. Public

A member of the public expressed concerns on behalf of a fellow resident, regarding planning application PF/23/2016. A previous application was rejected and they did not feel the new application addressed the reasons for the rejection. The scale, size and light pollution from the proposed building were the main areas of concern. The applicant was in attendance and explained for the campsite to be viable, the existing facilities were not adequate and more modern facilities were needed. The applicant stated the light pollution would not cause a problem and the neighbours would not see the proposed building. Many changes had been made to the original plans to satisfy the planning department's concerns, including size, location and colour. The applicant also stated the campsite had planning permission to be a campsite a long time before the neighbouring properties were built. Cllr Price highlighted decisions for planning applications were the responsibility of North Norfolk Council.

5. Matters Arising - TO RECEIVE UPDATES

a. To agree details of climbing wall opening

The opening of the climbing wall was set for Friday 20th October at 3.30pm. Ribbon and a plaque had been sourced and councillors had been encouraging the attendance of residents. A Facebook post has been published to promote the occasion.

b. To update on progress of application for defibrillator funding

The clerk had started the application but needed confirmation of the exact location in Cangate. It was AGREED it would be on Cangate Road at the junction of the unadopted road. It was also AGREED that the other two locations defibrillators were wanted were the staithe and the green opposite the school. The clerk would apply for other funding available to source this.

c. To update on the quote received for clearance of the permissive footpath

A quote had been received for £250 for ten cuts of the path between April and October or £50 for a one-off clearance. It was AGREED the community should be asked for their views on the parish council paying for the path maintenance.

The clerk reported this matter was discussed with the highways department who confirmed it is their responsibility to remove the posts and this will be actioned when resources allow.

i. To receive update on SAM2 data analysis

There was no data available at the meeting due to the absence of Cllr Rutter. The clerk confirmed should a new location for the camera require a post, the cost would be £195 plus possible traffic management fees. It was AGREED that feedback from the community would be sought on possible locations.
